Summary of the methodology

The verification was conducted based on NDPE-IRF protocol on 27th – 30th May 2024. The compiled IRF profile of 35 refineries for the reporting year January-December 2023 are provided and assessed prior to the date of assessment. Bunge as the data aggregator has been verified and complies with the requirement of the NDPE IRF Verification Protocol. In 2023, only Pasir Gudang facility received materials directly from palm oil mill whereas the remaining facilities received their materials from another supplier such as refinery/trader.

Conclusion

Control Union's responsibility was to exclusively verify the accurateness and completeness of the IRF methodology and processes for the calculation of the IRF profiles for the facilities in the scope of the assessment. Based on the information and evidence presented to Control Union, Bunge as the data aggregator has been verified and found compliant with the methodology detailed above.
